**REGISTRATION DEADLINE** to participate in benefits which apply to eligible registered bands for Carifesta Carnival 2011 is March 31<sup>st</sup>, 2011. There is a late registration fee of \$100 for applications received after March 31<sup>st</sup>, 2011. The total cost to participate is:

\$1,000.00\* for costumed bands and  
\$1,500.00\* for non-costumed bands

***\*It is the responsibility of each band to secure a sound system as the price of participation does not include it. However, CCFA can assist in reserving a standard sound system (16 KW) for an additional cost of \$1,800.00.***

CCFA will be collecting the fees by **certified cheques or money orders** as follows:

\$250 deposit upon signature of the current agreement by March 31<sup>st</sup>, 2011 at 11h59 pm  
\$375 (costumed bands) and \$625 (non-costumed bands) by April 30<sup>th</sup>, 2011 at 11h59 pm  
\$375 (costumed bands) and \$625 (non-costumed bands) by May 31<sup>st</sup>, 2011 at 11h59 pm

Please make your **certified cheques or money orders** payable to **Caribbean Cultural Festivities Association**. All registered bands must participate in the Carifesta Carnival Launch to be eligible for benefits. A SELECT FEW NON-COSTUMED BANDS OR SECTIONS are allowed in the parade. All payments and signed registration forms must be returned to Caribbean Cultural Festivities Association (CCFA) at the above address.

The parties hereby represent and warrant that (a) it has the right and authority to enter into this agreement and (b) the execution and performance of this agreement will not violate or conflict with the provisions of any agreement by which it is bound.

I hereby agree on behalf of myself and all members of my band, and the Designer and Producer of the above presentation, to adhere to and comply with all the rules (of which I am in possession and have read) as stipulated by CCFA for 2011. I submit to the sanctions therein contained and agree that nothing shall limit the right of CCFA to record, film, videotape and broadcast and to transmit via the internet the performance of the said presentation at any event produced by CCFA. It is expressly agreed that CCFA may employ or authorize any third party, including the media, to exercise these rights on its behalf. I acknowledge that I am aware of the benefits offered to registered bands in 2011.
